1. Outcome of the final notification of MoUD, GOI.
2. Payment of salary to the staff (both teaching and non-teaching) is to be made as per ongoing CPC.
3. Appointment of additional teaching and non-teaching staff, due to upgradation of the school, as per requirement and RRs laid down by the Department.
4. The school shall dispense away the services of the over-aged teachers and shall appoint teachers as per RRs.
5. Maintenance of DRF account.
6. Railing on each floor must be raised for the safety of the students and submit the compliance within 03 months.
7. That the school shall appoint Medical Officer/Staff in the school.
8. Compliance of provisions of DSEAR, 1973, Court Orders, guidelines of DoE in maintenance & use of school's account/fund.




